

OFF LICENCE



Licence No: 49D/OFF/265/2023

PURSUANT to the Sale and Supply of Alcohol Act 2012, **Husk Bar Wellington Limited** (the licensee) is authorised to sell and supply alcohol on the premises situated at **62 Ghuznee Street, Te Aro, Wellington**, and known as **Choice Bros Ghuznee St**, to any person for consumption off the premises and to supply alcohol free, as a sample for consumption on the premises. The licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else. (Remove if licence endorsed under section 40)

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

The licence is subject to the following conditions:

1. Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied free as a sample for consumption on the premises, seven days per week, only on the following days and hours:

Monday to Sunday 8.00am to 9.00pm

2. No alcohol is to be sold on, or delivered from, the premises on Good Friday, Easter Sunday or Christmas Day or before 1.00 pm on Anzac Day.

3. While alcohol is being supplied free as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.

4. The Licensee must have available for consumption off the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of nonalcoholic and low-alcohol beverages.

5. Only beer, wine and spirits brewed, fermented or distilled by the applicant may be sold under this licence for off-site consumption.

6. The part of the premises known as the Lounge Area, marked in blue on the plan of the premises submitted with the application date stamped 21 August 2023 is designated supervised at all times. Until 8.00pm the rest of the premises is not designated. From 8.00pm the whole of the premises is designated supervised.

7. A properly appointed certificated or Acting or Temporary Manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises.

8. The Licensee must display:

- At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons; Page 5
- At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol;
- A copy of the licence attached to the inside of the premises so as to be easily read by people entering each principal entrance.

The premises are as set out on the plan submitted with the application and date stamped 21 August 2023.

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the renewal, suspension and cancellation of licences, this licence expires on:

12 September 2026

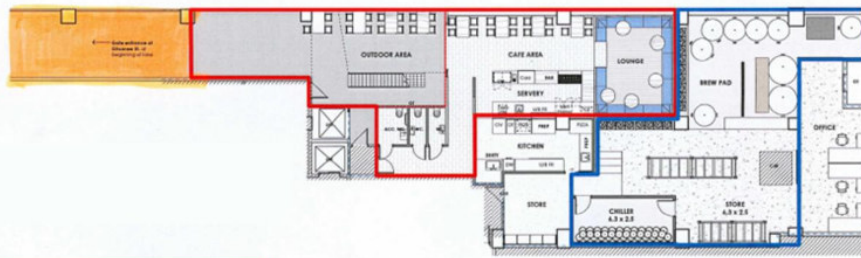
